TERMS AND CONDITIONS OF VEHICLE RENTALS CUSTOMER CAR RENTALS USE RENTED VEHICLES AS SERVICE REPLACEMENT VEHICLES.

Is your car being serviced and you need to borrow a replacement vehicle? Use the services of our car rental and borrow one of many vehicles in our car rental at a reduced price tariff "Replacement car for ½ day".

For the customers of Autocentrum BARTH a.s. who place their vehicle in our service for servicing (standard service, change of tires, minor repairs etc.) which is to be finished within one day, have the option to borrow a replacement vehicle of the same or similar class from our BARTH Rent car rental for the time of the repair works at advantageous terms for / day. The security deposit is not required in this case.

A vehicle of an upper class may be borrowed. (A security deposit is required in this case.) The rental is provided at significantly reduced prices, therefore no further discounts can be granted.

### Reduced prices at "Replacement car for ½ day" tariff

The "Replacement car for ½ day" reduced price tariff is valid only if the vehicle is collected and returned on the same day. If the vehicle is returned on a different day, the rent payment is charged at the daily tariff. The rent payment includes max. 150 km travelled during the given day on which the vehicle was rented. In the event of travelling more kilometres, the charge of 3,- CZK without VAT per kilometre travelled shall be charged.

## GENERAL TERMS AND CONDITIONS OF VEHICLE RENTALS IN THE CAR RENTALFF

### Age and Documents

The Renter shall reach the age of 18 and be an authorised holder of the driver's license, group B, for at least two years. With sports, off-road and luxury vehicles, the Renter shall be an authorised holder of the driver's license for more than 4 years. The vehicle will be leased on production of two identity documents (identity card and driver's license) issued in the Czech Republic only. A trade license or a copy of an entry in the Commercial Register is required with corporations. The vehicle may only be driven by the Renter or individuals listed in the rental agreement as other drivers (meeting the same criteria as the Renter). It is forbidden to smoke in the vehicle or make any adjustments to it (through sticker pasting, drilling, screwing, disassembly of parts etc.).

### Takeover and Return of the Vehicle

The vehicle is handed over clean and tidy with a full tank of fuel and shall be returned in the same state. The vehicle shall be taken over from 7.30 am of the first day of rental and returned by 5.00 pm of the last day of rental on working days (Monday - Friday) unless agreed with the Lessor otherwise. The days of vehicle takeover and return are charged as one rental day. The places of takeover are the business premises of Autocentrum BARTH a.s. in Pardubice or in Hradec Králové.

Our vehicles in BARTH Rent car rental are located mainly in the business premises in Pardubice Dubina where the takeover and return take place. Some vehicles are located in the business premises in Hradec Králové. A vehicle may be taken over in the business premises of your choice for a supplementary charge (you make the choice when making a booking at our booking website).

### Security Deposit

The vehicle is handed over against a refundable security deposit, the amount of which is indicated by each vehicle on our website (the security deposit is not required with the "Replacement Vehicle for / day" tariff where at the same time your vehicle is being serviced by Autocentrum BARTH a.s.) The security deposit is also not required from the customers who make their payments for servicing works against invoices as agreed with Autocentrum BARTH a.s. The security deposit may be paid at the time of vehicle takeover by pay card or by non-cash payment within 7 working days prior to the time of vehicle takeover (cash payments are not possible). The security deposit is intended for possible damage not covered by the accident insurance, irremovable fouling and damage of the vehicle interior.

### Insurance

The vehicles are covered by liability insurance covering damages incurred from operating a vehicle with territorial validity specified by the green card and by an all-risk accident insurance policy with 10 % deductible, 10 000 CZK minimum (ŠKODA vehicles have a 5 % deductible, 5 000 CZK minimum). In the event of a claim, the deductible shall be subtracted from the security deposit. If a vehicle accessory is damaged or lost, the accident insurance does not apply, as well as in the event of a third party break-in or theft of the accessory or items placed inside the vehicle. Such damages shall be subtracted from the security deposit. Shall the above-mentioned security deposit not suffice to cover damages incurred or the deductible, the Renter is obliged to settle the difference within 5 working days.

### Kilometres Travelled - Rentals for up to 28 Days

You are not limited by the number of kilometres travelled with us. We do not charge any fees per kilometre.

### Kilometres Travelled - Rentals for 1 Month and More

Monthly rental rates are set for the maximum of 3 000 km / month travelled. In the event of travelling more kilometres, every kilometre travelled over the limit shall be charged at the rate specified in the Rental Agreement.

### The Rental Price

The price for the rental of our cars includes: winter and summer tires depending on the season, the green card, car radio, full liability and accident insurance (accident, theft, natural disasters) within the Czech Republic and EU, compliance with all the compulsory checks (MOT, emissions) and road tax. We do not charge any fees for trips abroad. We do not charge any fees per kilometre or other hidden fees with regular one-day rentals.

### Price Reductions

Prices of the rentals in BARTH Rent car rental are reduced and it is therefore not possible to grant any further reductions or discounts.

### Payment Terms - Rentals for up to 28 days

After the booking, the Renter shall receive a booking sheet by email and with rentals over 10 000 CZK incl. VAT also a pro forma invoice for a deposit payment. The Renter is obliged to pay the deposit of 30% of the total rent as a reservation of the rental date within 3 working days. Thereafter the Renter shall receive a Rental Agreement by email to sign, one signed copy of which the Renter shall send back to the Lessor by post within 3 working days. The rental balance due shall be paid by the Renter non-cash by 7 working days prior to the vehicle takeover. The customers who make their payments for servicing works against invoices as agreed with Autocentrum BARTH a.s. may make the rent payment by transfer order, against an invoice. The security deposit shall be paid by the Renter non-cash prior to the vehicle takeover, or by credit card at the time of vehicle takeover.

### Payment Terms - Rentals for 1 Month and More

When renting a vehicle for more than 1 month, it is necessary to pay the rent monthly in advance (for the first rental it is noted that the rent for the first month shall be paid prior to the vehicle takeover). The customers who make their payments for servicing works against invoices as agreed with Autocentrum BARTH a.s. may make the rent payment by transfer order, against an invoice.

### Sanctions

For the loss of vehicle keys, the vehicle registration certificate, green card, service book or other documentation, the contractual fine of up to 5 000 CZK for every lost item shall be charged by the Lessor. If the vehicle is returned in an excessively dirty condition, the Lessor shall charge a contractual fine of up to 5 000 CZK. If the vehicle is returned later than agreed in the Rental Agreement, the Lessor shall charge a contractual fine of up to 10 000 CZK for every 24 hours of delay or part thereof.

### Accidents and Breakdowns

The Renter is obliged to inform the Lessor about any damages promptly by phone. In the event of any accident, natural disaster, a third person break-in or vehicle theft, the Renter is obliged to inform the police about the incident and request a report of performed inspection. The vehicles are covered by the producer's warranty. Possible repairs need to be carried out by authorised repairers and on production of a service book to require a repair for free, unless agreed with the Lessor otherwise. (Assistance services in an extended scope have been arranged in case of an accident, breakdown, natural disaster or theft.)

### Cancellation Policy

In the event of withdrawal from the contract by the Renter, the Lessor charges a withdrawal fee of 30 % of total agreed rent with withdrawals from the contract between 31 to 60 days prior to the agreed first day of rental, 50 % of total agreed rent with withdrawals from the contract between 11 to 30 days prior to the agreed first day of rental and 100 % from the agreed rent with withdrawals from the contract 10 or fewer days prior to the agreed first day of rental or with failure to appear and take over the vehicle on the agreed date or failure to comply with the terms of the vehicle takeover. Upon early termination of the rental period the unused part of the rent shall not be refunded.
